Description of Divorce :

Pertaining to the suite of plaintiff Mr. Roozbeh Niroomand as the attorney of Ms. Mahsa Ghane , father's name Jamshid , versus Mr. Hooman Abadi , father's name : Gholamreza , claiming for issuance of non-compromise Certificate and excerpt and fault due to leaving the matrimonial life by the defendant as per the plea submitted to the court and considering the contents of the classified file and marriage certificate No. 19094 date July 13, 2011 by notary public No. 30 of Someesara and by attaining the matrimonial relationship between spouses and as per the marriage certificate and whereas according to Art. 1119 of Civil Code the parties to the marriage contract can add any conditions which are not included or are against the marriage , during marriage contract and since the wife has power of attorney on behalf of the husband and is appointed as the attorney and the condition is proved right , she may have the right to divorce herself . the conditions during contract by consideration of the fact that husband has left the matrimonial life and as per clause 8 of marriage contract is proved and the court has performed the research from the witnesses of the plaintiff and all witnesses and referees stated that the defendant has left the matrimonial life over one year and wife is domiciled in her father's house and they were living there as from the time of marriage and husband has left her from that house . attorney of plaintiff has stated that the wife granted one Bahar Azadi Golden Coin from her marriage portion and demands the rest. Spouses do not have common child . wife has no claim pertaining to dowry and remuneration and will demand the rest of rights separately . according to art. 26 of Family Law the type of divorce is Compensation .

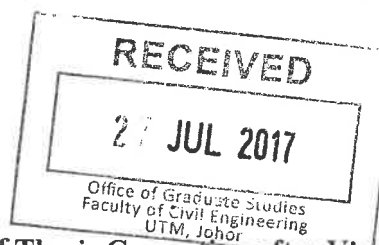

With reference to the above subject and particulars, I am writing to apply for an extension of six (6) months for the submission my thesis correction. I sat for my final viva at SPS on 3 November 2016, which unfortunately resulted in major correction. My thesis correction submission deadline is November 2017. However, I am unable to complete my corrections in time due to a pressing family problem which demands my time and attention that I cannot concentrate on my work at all.

Actually, when I started my PhD in UTM, I got married but later my wife wanted a divorce. I did not divorce her then since I did not want to divorce. Not long afterwards, she went back to our country, while I continued to work on my research here in Malaysia.

After the final viva, I decide to go back to country for a while to work things out and reconcile with my wife, before working on my corrections. Things took longer than I initially estimated and before I knew it it, I already spent around 5 months in my country. With all those months and effort, I really thought everything was fine, so I come back to Malaysia and started my work. I was determined to finish my correction as soon as possible and go back to my country to start my life with her. However, about one month ago my parents called me up and said that I needed to go back and settle everything again. My wife has already submitted her divorce request in court and demanding an enormous amount of dowry. On top of that, my wife has also opened a new case in court which stated that I have disappeared without a trace. Hence, I need to go back immediately to handle the dowry issue and to prove that I did not disappear anywhere but still a student in Malaysia until finish my PhD research.

If I do not go back to my country and try to find a solution for this problem, my wife would take everything from me and my family. I would then be in financial difficulty and cannot afford to continue my stay in Malaysia to complete my study. I cannot allow this to happen because my parents are retired and need care.

I hope you can understand my predicament. I really need your help to extend my submission date to May 2018.
